

## **Event terms and conditions**

### **Business Insider Global Trends Festival**

#### § 1

The terms used in these terms and conditions shall be deemed to mean the following unless the context of these Terms and Conditions clearly indicates otherwise;

1. **Ticket** – an electronic confirmation of purchase from the Evenea service entitling to participation in the Event organised by the Organiser.
2. **Event** – the virtual conference-business event under the name of “Business Insider Global Trends Festival” organised by the Organiser
3. **Event website** – the [www.trendsfestival.com](http://www.trendsfestival.com) website where the event will be taking place on virtually.
4. **Organiser** – Ringier Axel Springer Polska Sp. z o. o. ul. Domaniewska 49, 02-672 Warsaw, EU VAT ID: PL5272677009.
5. **Terms and Conditions** – these event terms and conditions defined by the Organiser, defining the rights and obligations of the Organiser and of the persons the Organiser involves in organising the Event, relating to the delivery of the Event, as well as the rights and obligations of the Attendees.
6. **Ticket Sales Terms and Conditions** – the terms and conditions of online sales of the tickets to the event available on the <https://evenea.pl/pl> website
7. **Attendee** – a ticketholder.

#### § 2

##### The Event

1. The Event will take place from 19 to 23 October 2020 in a virtual form on the Web on the [www.trendsfestival.com](http://www.trendsfestival.com) Event website.
2. The Event will be held in the English language according to the Event agenda published on the Event Website not later than 3 days before the Event begins.
3. The Event may be attended by persons who have purchased the Ticket via the <https://evenea.pl/pl> portal or have received a ticket from the Organiser and subsequently have registered for the Event at the [www.evenea.com](http://www.evenea.com) website to take part in the Event. Possession of a Ticket (in the electronic form) and the registration to the event are the conditions of participation in the Event.
4. The Organiser reserves that for reasons beyond the Organiser’s control there may be changes to the speakers, Event agenda, time or place of the Event or the Event may be cancelled altogether. In such an instance the Organiser shall inform without delay the Attendees about the situation by publishing the relevant information on the Event Website and by emailing it to the Attendees to their email addresses indicated in the form on the [www.evenea.pl](http://www.evenea.pl) website. In the case of change of date or place of the Event the Ticket remains valid for the new date or place of the Event.

5. In the case of complete cancellation of the Event, the Organiser shall refund the price of Tickets on the terms and conditions defined in the Ticket Sales Terms and Conditions.

### § 3

#### The obligations of the Attendees

1. The Attendees shall:
  - 1.1. observe the provisions of the Terms and Conditions,
  - 1.2. behave in a manner that meets the rules of social conduct, in particular shall not pose danger to the other Attendees, shall not formulate any content of offensive nature, with negative connotations and infringing on the rights and dignity of the Event Attendees, the Organiser and any other persons,
2. The Attendees shall have no right to record, use or transmit the recordings of sound or video of the Event.
3. During the Event the Attendees shall not conduct any commercial, for profit, advertising or promotional activities whatsoever unless permitted to do so by the Organiser in advance in writing.

### § 4

#### The rights of the Attendees

1. The Attendees shall have the right to obtain from the Organisers the necessary assistance concerning the operation of the Event.
2. The Organiser shall not be liable for the proper operation of the Internet and any related problems with the reception of the Event by the Attendees. The Attendees hereby agree and acknowledge that the Organiser has no control over any problems with the reception of the Event that occur for reasons beyond the control of the Organiser.
2. The Attendees shall have the right to lodge with the Organiser any complaints concerning the progress of the Event and the damages they incurred. The complaints should be mailed in writing to the address of the Organiser or emailed to [help@trendsfestival.com](mailto:help@trendsfestival.com).

### § 5

#### Intellectual Property Rights

1. Any and all lectures, presentations, training videos, etc. delivered and presented during the Event constitute work within the meaning of the Act of 4 February 1994 on the Copyright and Related Rights (Polish Journal of Laws of 2016, item 666, with subsequent amendments), with the material rights thereof belonging to the Organiser or the persons presenting the specific work, in particular, the speakers.
2. The Attendees hereby grant their consent to the Organiser to take photographs and videos during the Event that may determine the likeness of the Attendee, subsequently used for information, promotional and marketing purposes. In the case of not granting their consent,

the Attendees shall inform the Organiser to that effect within 3 days of the end of the Event at the latest.

## § 6

### Data Protection

1. The data controller of the Attendee's personal data is Ringier Axel Springer Polska sp. z o.o. (Warsaw, Poland). The Attendee's Personal Data contained in the registration form is processed for the purposes of participation in the Event. In the field of personal data protection processed for the purposes of organizing the Event, the Attendees' personal data processor is EventLabs Sp. z o.o. and Intrado Digital Media AB. The Attendee's personal data is provided freely, but it is necessary for the registration for the Event. The processing thereof is based on your consent granted above. The data shall be processed for the period of the event duration and within the limitation period for any claims. You have the right to withdraw your consent at any time by sending an email to [pomoc@grupaonet.pl](mailto:pomoc@grupaonet.pl), which will not affect the lawfulness of the data processing before its withdrawal. You have also the right to access your personal data, rectify, erase or restrict its processing, the right to data portability, the right to object to the processing as well as the right to submit a complaint to Data Protection Authority in Poland - the Chief of the Office for the Protection of Personal Data. 2. In the case of the use of Your Personal Data for marketing purposes, this will be done only on the basis of consents received in this respect.

### Final provisions

1. All matters not dealt with in these Terms and Conditions shall be governed by the provisions of the Polish Civil Code.
2. In the event of a dispute between the Organiser and an Attendee, the competent court shall be the competent public court as defined by the laws in force.
3. The Organiser reserves the right to introduce changes to the Terms and Conditions within 14 days of informing the Attendees. In such a case the Organiser shall inform the Attendees to that effect without undue delay. The information about such changes shall be published on the [www.trendsfestival.com](http://www.trendsfestival.com) website.
4. These Terms and Conditions enter into force as of 30.07.2020.
